#### **English Goat Breeders Association – Cup for Best in Show (classes 27-29)**

All exhibitors are eligible to be awarded a cup, however for an exhibitor to leave the showground with a cup, they need to be a paid-up member of The Norwich & District Goat Club.

Cup winners will be asked to return the awarded cup/s in the 1<sup>st</sup> instance to the NDGC Christmas Social or at the very latest to the NDGC AGM held in February.

It is the responsibility of the exhibitor to ensure that awarded cups are returned, cleaned, in good overall condition and have been labelled as awarded.

Failure to return cups when requested or return cups in poor condition will result in the exhibitor being prohibited from being allowed to leave future shows with awarded cups.

Exhibitors will be requested to sign the cups form upon receipt of a cup.

The cup awarded to the Best in Show for the English classes will need to be returned to the EGBA secretary.

## Requirements set out by The British Goat Society & The Wayland Agricultural Society

### **British Goat Society recognised show – Sunday AM**



All goat classes are held under the Rules & Regulations recognition of The British Goat Society. All exhibits must be registered with The British Goat Society as in the name and ownership of the exhibitor; the registered name, number and earmark being quoted on the entry form, along with the kidding dates of goats in milk.

All goats in milk must have kidded or aborted at least 30 days prior to the date of the show (4<sup>th</sup> July 2025).

No pregnant goat may enter the showground. In the event of an unforeseen kidding or abortion taking place, the goat must immediately be isolated from other goats. Full details of goat exhibitor and action taken must be reported in writing by the Chief Steward to the BGS Secretary immediately after the show.

Kids need to have been born on or prior to 3<sup>rd</sup> June 2025.

The registration number or earmark number of any goat entered must be submitted to the show secretary before the goat competes in the show and will be checked.

Attached Declaration form must be completed and returned with entries.

#### C.A.E.

**A copy of the current C.A.E whole herd certificate must accompany your entry form alongside the latest BGS CAE submission form completed by the vet at the time of the test taking place.**

All goats must have a valid C.A.E test certificate and must have tested negative within the last 12 months prior to the show. The certificate must show the earmark of the goat. Please note kids must have proof of being from a negative tested dam. Exhibitors are asked not to bring to the show any goat that has EVER had a positive reaction to a C.A.E test. Herds will be penned separately wherever possible.

#### Booking in

**All goats in milk & being shown for the BGS recognised Sunday AM show must be on the showground by 5:30 on Saturday 2<sup>nd</sup> August 2025 and must be stripped out by the appointed stewards by 6:30. Arrival will be the livestock exhibitors' entrance via Brandon Road, Watton. (Signage will be up)**

**Udder inspection will be 7am on Sunday 3<sup>rd</sup> August 2025, immediately followed by milking which must be completed by 8:30am**

**Exhibitors with youngstock to be shown in the AM show can arrive before 7am or will need to wait to be penned after the milking, the marquee will be closed whilst milking takes place.**

Upon arrival, please make contact with the Chief Steward or Show secretary, all goats MUST be penned in the pens allocated and vehicles moved to the designated exhibitor parking – no vehicle movements are allowed whilst the show is in progress, animals can only leave the showground 5pm onwards.

Exhibitors MUST bring a completed Animal Movement Licence and a second semi-completed for the return journey. Please hand these in to the secretary, homeward bound licences will be issued before departure.

**Requirements set out by The Wayland Agricultural Society and The Norwich & District Goat Club**  
**English Female Breed Show & NDGC Club Show – Sunday PM**



All goats in milk must have kidded or aborted at least 30 days prior to the date of the show (4<sup>th</sup> July 2025).

No pregnant goat may enter the showground. In the event of an unforeseen kidding or abortion taking place, the goat must immediately be isolated from other goats. Full details of goat exhibitor and action taken must be reported in writing by the Chief Steward to the Secretary immediately after the show.

Kids need to have been born on or prior to 3<sup>rd</sup> June 2025.

The registration number or earmark number of any goat entered must be submitted to the show secretary before the goat competes in the show and will be checked.

Attached Declaration form must be completed and returned with entries.

**C.A.E.**

**A copy of the current C.A.E whole herd certificate must accompany your entry form. Preferably on the latest BGS CAE submission form (1.12.24) completed by the vet at the time of the test taking place. For those exhibitors showing goats in this show only & who are not members of the BGS, please leave the BGS herd reference number blank. The submission form is available to download from the BGS website or via contacting the BGS office.**

All goats must have a valid C.A.E test certificate and must have tested negative within the last 12 months prior to the show. The certificate must show the earmark of the goat. Please note, kids must have proof of being from a negative tested dam. Exhibitors are asked not to bring to the show any goat that has EVER had a positive reaction to a C.A.E test. Herds will be penned separately wherever possible.

**Booking in**

**All goats being shown for the NDGC Sunday PM show must be on the showground by 8:30AM. For those with entries into both the AM & PM shows, please contact the Secretary or NDGC Chair for clarification.**

**Arrival will be the livestock exhibitors' entrance via Brandon Road, Watton. (Signage will be up)**

Upon arrival, please make contact with the Chief Steward or Show secretary, all goats MUST be penned in the pens allocated and vehicles moved to the designated exhibitor parking – no vehicle movements are allowed whilst the show is in progress, animals can only leave the showground 5pm onwards.

Exhibitors MUST bring a completed Animal Movement Licence and a second semi-completed for the return journey. Please hand these in to the secretary, homeward bound licences will be issued before departure.
